Minutes of the SFPE – NJ Chapter Meeting October 2 , 2017

President Paul McGrath called our Oct 2 meeting to order at 6:00PM with a salute to the flag and introductions of the 25 people in attendance.

The Secretaries report for September was accepted. The Treasurer's report for September was accepted.

Paul announced that our November 9 meeting will be the field trip to Tyco's labs in Cranston, RI. The bus will be leaving from the FM Global parking lot at 6:00AM sharp and will be back by 6:00PM. Seating is limited so make your reservations soon.

Award presentations will soon be made to our two 2017 Fire Prevention Week Grant Program winners. Paul

McGrath and Dave Gluckman will be delivering \$500 checks to Wallington and Somerset County. Next year's grant topic will be Carbon Monoxide alarms. Rich Reitberger mentioned that the Education Foundation will consider providing matching awards to our 2018 FPW Grant Program.

Hefty insurance claim settled after deadly Tianjin blast in 2015

TIANJIN, Sept. 26 (Xinhua) -- More than 8.1 billion yuan (about 1.2 billion U.S. dollars) of insurance claims related to two huge explosions in Tianjin had been settled as of the end of 2016, said Tianjin Bureau of China Insurance Regulatory Commission Tuesday.

Two warehouse explosions rocked Tianjin on Aug. 12, 2015, claiming 165 lives. The blasts led to one of the most costly catastrophe claims for the Chinese insurance sector in years.

By the end of last year, over 6,000 insurance claims were settled. The total settlement amount is expected to exceed 10 billion yuan, the bureau said.

Auto makers and dealers who had warehouses close to the blast site were among the most affected.

China Automobile Trading lost 3,000 imported vehicles in the blasts, the biggest single loss, the bureau said. China Continent Insurance paid 1.73 billion yuan (266 million dollars) to the company in January 2016.

"Many of the bigger cases were settled in 2016. Smaller claims will be settled one by one," said Zhang Zhihuai, deputy director of Tianjin Insurance Association.

A total of 101 insurance organizations were involved in emergency response after the blast, Zhang said.

3,000 people evacuated, helicopters deployed as market outside Moscow erupts in flames



A fire has broken out at a busy building supplies market just outside of Moscow to the north-west. Plumes of black smoke could be seen rising from the site, with around 55,000 square meters (592,000 square feet) of the premises reportedly ablaze.

The popular Sindika market has been on fire since Sunday afternoon.

Around 3,000 people have been evacuated from the site, emergency services reported.

Three people were injured in the fire, having suffered from smoke inhalation. One had to be hospitalized.

Witnesses reported hearing explosions, as TASS news agency, citing sources in emergency services, said several cars exploded in the market's underground parking.

When the fire broke out, customers fled the building in panic, according to eyewitnesses.

Three helicopters have been deployed to deal with the blaze, emergency services reported, adding that around 230 tons of water have been dropped by helicopters on the burning structures.

The firefighters managed to contain the blaze by 11pm local time. It is not yet clear what caused the building to go up in flames. The investigation into the causes of the fire will be led by forensics experts from the Russian Emergencies Ministry.

At least 400 square meters (4,305 feet) of the market building have collapsed, the local emergency services official told Ruptly.

More than 1,200 shops are located on the premises of the construction market, which occupies around 130,000 square meters (32 acres). The estimated damage from the fire is some 5 billion rubles (\$86 million).

American Airlines 777-300ER: Cargo Bin Catches Fire in Hong Kong- Oct 9, 2017

MIAMI — An American Airlines Boeing 777-300(ER) was involved in a fire incident while being loaded at Hong Kong's Chek Lap Kok International Airport at 17:30 local time.

The 2014-delivered aircraft was reportedly being prepared for its scheduled flight AA192 to Los Angeles when a cargo bin caught fire.

According to Martha Thomas, a spokesman for American Airlines, a cargo container caught fire as it was being loaded into the rear cargo compartment of the aircraft.

The airline spokesman clarified that "an external piece of loading equipment had a mechanical issue and caught fire while preparing to put cargo in the hold of American Airlines flight 192 from Hong Kong (HKG) to Los Angeles (LAX) (...) As a result, a pallet on the loading equipment containing non-hazardous goods also caught fire."

Even though the flames affected the container that was about to be loaded into the aircraft, the condition of the Boeing 777 remains unknown. However, the proximity of the flames to the aircraft's fuselage may have caused some structural damage. The flight to Los Angeles has been canceled until further notice.

American Airlines flies daily to Hong Kong on its flagship, the Boeing 777-300(ER). The airliner is equipped with eight First Class suites, 52 Business Class, 30 Premium Economy and 220 Economy seats.
